Privacy Protection of Information

Acknowledgement and authority that credit information may be given to a credit reporting agency. I understand that section 18E(8)(C) of the Privacy Act allows the financier to give a credit reporting agency certain personal information about me which I authorise the financier to do so. The information which may be given to a credit reporting agency is covered by Section 18E(1) of the Act and includes:

- Payments which become overdue more than 60 days

- In specified circumstances, that in the opinion of the Financier I have committed a serious credit infringement
